Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 22nd day of May, 1963, I found the Quarter corner of Sections 29 - 30 which was evidenced by the remains of the GLO resurvey of 1926 Iron post 1 inch diameter with brass cap stamped:-

Maple 12 inch S84°30'E 67 links (44.22 feet) (Now a 22 inch dead
 Maple S85°E 44.22 feet with scribe overgrown.)
