Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 4th day of January, 1963, I found the Quarter corner of sections 28 - 33 which was evidenced by the remains of a survey by the General Land Office in 1926.

Found a 1 inch diameter iron post with a brass cap stamped $\frac{1}{4}$ S28
S33
Maple 6 inch N42°E 19 links or 12.54 feet (now a 15 inch maple 1926
N47°E 12.54 feet with scribe visible.)
Maple 10 inch S25°E 5 links or 3.3 feet (now a 15 inch maple S33°E 3.3 feet.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.


