William H. Ockerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 2nd day of June, 1964, I found the Quarter corner of Sections 5 - 8 which was evidenced by remains of the G.L.O. resurvey of 1937. Corner was found to be marked with an iron pipe 3' x 1" in diameter with brass cap marked:

Ash 6" N57 1/4°E, 4 1/2 links marked 1/4 S 5 BT. Found 9" at record bearing 1/4 S 5/8 1937 and distance, scribe overgrown.

Elm 8" S80°W 37 links marked 1/4 S 8 BT. Found 12" at record bearing and distance, scribe overgrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of existing G.L.O. monument which was good.
