





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 20th day of June, 1966, I found the Quarter corner of Section's 25-26 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long 1 inch in diameter with brass cap marked

Aspen 6 inch S58-3/4°E 31 links or 20.46 feet - Now a 14 inch Aspen at correct bearing and distance - scribe visible.

Aspen 6 inch S20°E 14.35 feet - scribed 1/4 S25 BT.

Set a steel sign post 72 inches long with signs 54-2 and 54-4 attached due East 5.45 feet.
