That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 23rd day of June, 1966, I found the Quarter corner of Section's 24 - 25 which was evidenced by G.L.O. resurvey of 1937 a set iron post 3 feet long by 1 inch in diameter with brass cap marked:

Ash 6 inch  $S18\frac{1}{2}^{\circ}E$  28 lks or 18.48 feet - Now a 10 inch Ash at correct bearing and distance - no scribe or blaze visible.
