





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 25th day of October, 1965, I found the Quarter corner of Sections 10-11 which was evidenced by a 1 inch diameter iron pipe found 1 foot below road surface set by John Curo, County Surveyor in 1908.

Aspen 4 inch N69°W 48.47 feet (No BT's found all in clearing).


Cedar fence post 10 inch S87°W 36.85 feet.

Balm-of-gilead 6 inch N27°W 75.30 feet.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 24 inch long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped

.8 foot below road surface

from which reference or witness monuments are located in the manner following:

Cedar post 4x4x60 inches long with red top set N88°E 23.7 feet with Forest Service sign 54-2 attached.

Culvert 15 inches, North along centerline of road 233.2 feet.

All reference bearing are true bearings.
