## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 25-26 T. 145 N R. 28 W No. 6

Peter J. Meyer, being first duly sworn, deposes and says:  
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.  
I further depose and say that on the 2nd day of August, 1958, I found the 1/4 corner of sections 25-26 which was evidenced by two remaining original scribed bearing trees of the Government Survey of 1874. (1) 1 1/4 inch Red Pine (now 20 inch stump partly decayed with scribing B visible) S 84° W, 20 links or 13.2 feet. (2) 1 1/4 inch Jack Pine (now stump hole) S 80° E, 30 links or 19.8 feet.

Corner was found to be marked with a 3 inch squared post.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

1958  
R.L.S. 3628
