

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 3 - 34 T. 145 - 146 N. R. 27 W. No. 8

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 3rd day of July, 1958, I found the 1/4 corner of Sections 3-34 which was evidenced by two remaining original scribed bearing trees of the Government survey of 1874.

1. 8 inch Red Pine (now 19 inch with scribing visible) S. $34\frac{1}{2}^{\circ}$ E. 42 links or 27.7 feet.
2. 12 inch Red Pine (now 25 inch with scribing not visible - burnt out) N. 58° E. 7 links or 4.6 feet.

I checked and found no evidence of original Government corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe, filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

T. 146 N.-T. 145 N. R. 27 W.
1/4 3-341958
R.L.S. 3628

from which reference or witness monuments are located in the manner following:

Section 34	9 inch Jack Pine	N. 55° W.	10.9 feet

All reference bearings are true bearings.
