William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of April, 1964, I found the North Quarter corner of Section 4 which was evidenced by remains of the G.L.O. resurvey of 1930 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:

Found post as described. $\frac{1}{4}$ S4

Balsam 12 inch S35°E 27.70 feet - now decayed stump at record bearing and distance.

W. Pine 10 inch S46 3/4°W 13.90 feet - now 13 inch at record bearing and distance with scribing nearly overgrown. and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
