That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of November, 1965, I found the Quarter corner of Sections 1 which was evidenced by remains of the G.L.O. resurvey of 1930 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:
