William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 27th day of June, 1969, I found the Northwest 1/16 corner of Section 1 which was evidenced by remains of the G.L.O. resurvey of 1930, consisting of 1 inch diameter iron pipe, 3 feet long with brass cap marked. NW 1/16 S1
1930

Found pipe in place 14 inches above ground, south edge of small marsh.

Oak 12 inch S82°E 60.70 feet - scribed NW 1/16 S1 BT, found stump at record bearing and distance.

Birch 5 inch S71°W 63.40 feet - scribed NW 1/16 S1 BT, not found area has been slashed by pipeline.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
