



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Angle point for the original closing

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 16th day of May, 1963, I found the Angle point corner of Sections 1-2 which was evidenced by the remains of the G.L.O. resurvey of 1926.

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:-

Cedar 24* S10 $\frac{1}{2}$ °W 64 links (42.24 feet) (Now a 25 inch cedar at record bearing and distance with scribe visible.)

Birch 10* S30 $\frac{1}{2}$ °E 46 links (30.36 feet) (Now a 13 inch birch snag at record bearing and distance, scribe overgrown.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Cedar 17 inch S21°E 32.7 feet marked AP S1 BT

Cedar 8 inch S57°E 29.9 feet marked AP S1 BT

Closing corner of sections 1-2 bears North 48 links or 31.68 feet.

All reference bearings are true bearings.
