





Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 20th day of May, 1963, I found the North 1/16 corner of Section 11 - 12 which was evidenced by the remains of the G.L.O. resurvey of 1926.

Found a 1 inch diameter iron post with brass cap stamped:- N 1/16 marking corner.

Jack Pine 12 inch N17°E 30 links (19.80 feet)(Now a pine stub scribed "N 1/16 S12" at record bearing and distance.)

Jack Pine 8 inch N77¹/₂°W 46 links (30.36 feet)(Now a pine stump at roecord bearing and distance.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Oak 8 inch N55°W 40.4 feet marked N 1/16 BT

White pine 17 inch S58°E 62.4 feet marked N 1/16 S12 BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due south 4.8 feet.
