That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 11th day of December, 1961,

I found the Southwest 1/16 corner of Section 11 which was evidenced by the remains of the G.L.O. survey of 1926, notes of this survey are on file in the Minnesota state capitol - St. Paul, Minnesota.
