







## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 18th day of February, 1963, I found the Quarter corner of Sections 11-14

which was evidenced by the remains of the original Government survey of 1873.  
 Cedar 10° N 16 1/2° W 18 lks. (11.88') (Now cedar windfall at record bearing and distance with scribing visible.)

Cedar 10° S 16° E 16 lks (10.56') (Now partly dead with scribe decayed, at record bearing and distance.)

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:-  
 Set by the G.L.O. resurvey of 1926.

Cedar 9° S 16 1/2° W 31 lks. (20.46') (Now 8° cedar S 22° W 20.46' scribe decayed.)  
 and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GIO brass cap is in good condition.
