Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 1st day of December, 1961, I found the section corner of sections 11-12-13-14

which was evidenced by remains of two original pine bearing trees from the original gov't. survey of 1873. Norway pine 24" S35°E 87 links or 57.42' (now a 30" norway pine S26°E 57.42' with scribe T144N R29W visible)

Jack pine 10" S10°W 13 links or 8.58' (now a pine stump S10°W 8.6')

Corner was found to be marked by a 1" dia. 3' long iron post with brass cap mkd.

This post and cap was set by G.L.O. in 1926.
