....., being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 8th day of March, 1964, I found the Center West 1/16 corner of Section 23 which was evidenced by the remains of the G.L.O. survey of 1926. Corner was found to be marked by a 1" diameter iron post with a brass cap stamped:

Elm 8" S46°W 36 links (23.76') (now a 1 1/4" Elm S48°W 23.76 feet with scribe visible.)
