## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 28th day of August, 1962, I found the Meander corner of Sections 1 - 6 North bank Lydick Lake which was evidenced by one original bearing tree from the Government Survey of 1873.

Norway pine 20" N48°W, 32 links or 21.12' (now a 18" Red pine N48°W, 21.12')

Corner was found to be marked by a 6" diameter cylindrical concrete monument with a brass cap, set by G.L.O. in 1933. Two G.L.O. bearing trees were found, Norway Pine 9" S19½°E, 7 links or 4.62' (now 9" Red pine S29½°E, 4.62' scribe plain).

Norway Pine 9" N32½°E, 44 links or 29.04' (now Red pine N30°W, 29.04' scribe plain).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. corner is in good condition.

from which reference or witness monuments are located in the manner following:

Steel sign post 72" long set 24" in ground North 3.2 feet.

All reference bearings are true bearings.
