







William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 5th day of May, 1966, I found the Quarter corner of Sections 11-12 which was evidenced by G.L.O. survey in 1933

a set iron post 3 feet long by 1 inch in diameter with brass cap marked 1/4  
 Norway Pine 12 inch N41 1/2° E 181 lks or 119.46 feet - Now a 17 inch S11 | S12  
 N41° E 119.46 feet - scribe visible. 1933

Jack Pine 9 inch N20°W 113 lks or 74.58 feet - Now a stump hole and rotted wood.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap.

from which reference or witness monuments are located in the manner following:

Red Pine 9 inch N3°W 40.2 feet - scribed 1/4 S11 BT.

Jack Pine 9 inch N60°E 35.7 feet - scribed 1/4 S12 BT.

Steel sign post 72 inches long with signs 54-2 and 54-4 attached due East 4.6 feet.
