





William H. Okerman, being first duly sworn, deposes and says:
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 2nd day of May, 1966, I found the Center 1/4 corner of Section 13 which was evidenced by survey by G.L.O. in 1933 a set iron post 3 feet by 2 inches in diameter with brass cap marked C 1/4 SL3 1933

Tamarack 5 inch N75°E 9 lks / ^{OR} 5.94 feet (Now a 8 inch N75°E 5.94 feet) scribe visible.

Tamarack 5 inch N83°W 16 lks / ^{OR} 10.56 feet (Now a 3 foot high stub with scribe visible at record bearing and dist.).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new marker set, used G.L.O. brass cap

from which reference or witness monuments are located in the manner following:

B. Spruce 8 inch N29°W 25.2 feet (scribed C 1/4 SL3 BT)

B. Spruce 8 inch N89°E 20.5 feet (scribed C 1/4 SL3 BT)

Set a steel sign post with signs 54-2 and 54-4 attached due West 8.2 feet.
