

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
I further depose and say that on the 11th day of May, 1966,  
I found the Section corner of Sections 17-18-19-20 which was evidenced by G.L.O. resurvey of 1933  
a set 6 inch diameter concrete monument with brass cap marked  
Oak 7 inch N49<sup>1</sup>/<sub>2</sub>°E 58 lks or 38.28 feet - Now a 13 inch with scars of blaze visible at correct bearing.  
Oak 8 inch S81 3/4°E 72 lks or 47.52 feet - Now a 12 inch with scars of blaze at correct bearing.  
Oak 7 inch S74<sup>1</sup>/<sub>2</sub>°W 46 lks or 30.36 feet - Not found.  
Oak 7 inch N54°W 79 lks or 52.14 feet - Now a decayed stump at record bearing and distance.
