Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 29th day of January, 1962, I found the quarter corner of sections 25, 36 which was evidenced by an iron post 3 feet long, 1 inch diameter with a brass cap markd.

From which bears:-

Cedar 6 inches N10°E 26 lks. or 17.16' (now a 11" cedar N10°E 17.5' mkd. $\frac{1}{4}$ S 25 BT.) $\frac{1}{4}$ $\frac{S 25}{S 36}$ 1933

Cedar 8" S82°W 34 lks. or 22.44' (now a 10" cedar S82°W 22.66' marked $\frac{1}{4}$ S 36 BT.)

the iron post with brass cap was set by G.L.O. recurvey in 1933.

Notes of this survey are filed in the state capitol St. Paul, Minnesota.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set, used the G.L.O. brass cap as the corner.
