That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 17th day of May, 1966, I found the Quarter corner of Sections 31-32

which was evidenced by G.L.O. resurvey of 1933 a set iron post 3 feet long and 1 inch in diameter with brass cap marked 1/4
