That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 3rd day of April, 1964, I found the quarter corner of Section 33 which was evidenced by a monument set by G.L.O. in 1930 which is an iron post 36" long 2" dia. set 30" in ground with brass cap stamped:

Maple 10" N. 51 1/2° E. 25 links (scribed 1/4 S. 33 SC B.T.) (now a decaying log at record bearing and distance)
