 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 3rd day of April, 1964, I found the quarter corner of Section 34 which was evidenced by a monument set by G.L.O. resurvey of 1930 which is a 1" diameter iron post with brass cap stamped:

Aspen 7" N.51 3/4°W. 30 links (19.8)(now a 16" N.50°W. 20.1' scribe overgrown.

W.P. 36" N.70°E. 32 links (found at record bearing and distance scribe S. C.
