That I reside at Bemidji , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.....

I further depose and say that on the 21st day of October , 1965....., I found the East 1/16 corner of Section's 3 - 34 which was evidenced by remains of the G. L. O. resurvey of 1934 consisting of a 1 inch diameter post with brass cap marked
