

Statement of Evidence

East Quarter corner of Section 9, Township 135 North, Range 32 West, 5th Principal Meridian.

Oct. 1866 O.E. Garrison, General Land Office (GLO) Deputy Surveyor, in the notes of the subdivision of Township 135 North, Range 32 West, set a post for the original corner and notes no tree near. Said records are on file at the Minnesota Historical Society, St. Paul, Minnesota, copies are filed with the Cass County Surveyor's Office (CCSO).

Aug. 2004 B.Hippen, CCSO technician, records of the CCSO, set a 7/8 inch outside diameter iron pipe, stamped 16459, up 0.2 foot, in open pasture, midway and on line between the recovered northeast and southeast corners of Section 9 and witnessed as follows:

8" J. Pine	N 11° W	42.51 feet	6" J. Pine	S 74° E	36.73 feet
8" J. Pine	S 14° W	21.37 feet			

Aug. 2013 B.Hippen, CCSO technician, records of the CCSO, found the monument and witnesses from 2004. The monument, recovered and established references for the position are shown on the face of this document.

Analysis of the recovered record data, field evidence and survey measurements, indicates that the monument set by CCSO in 2004 is the accepted location of this corner.
