

Statement of Evidence

East Quarter corner Section 11, Township 137 North, Range 32 West, 5th Principal Meridian.

Dec. 1870 R. Cronk, General Land Office (GLO) Deputy Surveyor, notes for the subdivision of Township 137 North, Range 32 West, set a post for the original corner and referenced it as follows:
16" Tamarack N 44 1/2° W 30 links (19.80 feet) 14" Tamarack S 69 1/2° E 36 links (23.76 feet)
The above record is on file with the Minnesota Historical Society in St. Paul, Minnesota, copies are filed with the Cass County Highway Department, Surveyor's Office (CCHD/SO).

March 2015 B. Hippen, technician, records of the CCHD/SO, set 1.25 inch outside diameter iron pipe, up 0.4 foot, at lost position, midway and on line between the Northeast and Southeast corner of Section 11, in ash swamp and witnessed as follows:

6" Elm	N 4° W	31.96 feet	8" Ash	S 32° E	10.21 feet
8" Ash	S 66° W	23.72 feet	Sign Post	North	5.0 feet
Sign Post	East	5.1 feet			

The recovered and established references for the position are shown on the face of this document.

Analysis of the recovered record data, field evidence and survey measurements, indicates that the monument set by the CCHD/SO in 2015 is the accepted location of this corner.
