



1991 - WALT CURO SURVEY SHOWS SETTING N.E. CORNER OF SECTION 6

APRIL 2002 - WESTWOOD PROFESSIONAL SERVICES INC. PERFORMS SURVEY IN SECTION 6. WESTWOOD ESTABLISHES NORTHEAST CORNER OF SECTION 6 AT DIFFERENT POSITION THAN CURO. CURO CORNER WAS ESTABLISHED AT A FENCE INTERSECTION APPROXIMATELY 90 FEET NORTH OF ANOTHER FENCE INTERSECTION LABELED AS "WILSON FENCE" ON CURO SURVEY, HERB WILSON, ADJACENT LAND OWNER TO WEST SAYS THAT THIS IS FENCE LINE THEY HAVE OCCUPIED. THE POSITION AGREES FAVORABLY WITH THE ORIGINAL GOVERNMENT DISTANCE OF 5197.50 FEET TO THE SOUTHEAST CORNER OF SECTION 6. WESTWOOD MEASURES 5190.21 FEET TO THE SOUTHEAST CORNER OF SECTION 6. WESTWOOD ACCEPTS "WILSON FENCE LOCATION AS A PERPETUATION OF THE ORIGINAL CORNER.

AUGUST 2006 - WESTWOOD PROFESSIONAL SERVICES INC. TIES TO IRON PIPE SET IN 2002. OLD FENCE POST LOCATED IN 2002 REPRESENTING "WILSON FENCE CORNER" NO LONGER EXIST.
