

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6307.

I further depose and say that on the 22nd day of August, 1967, I found the Special Meander corner ~~mark~~ on West 1/16 line of Section 19 which was evidenced by remains of the G.L.O. resurvey of 1920, consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:

Found brass cap in place.

R. Oak 5 inch S41½°E 28.40 feet marked SMC S19 BT - now 11 inch at record bearing and distance, with scribe overgrown. SMC S19 1920
R. Oak 6 inch S39°W 33.70 feet marked SMC S19 BT - now rotted stump, parts of blaze in evidence. and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.

from which reference or witness monuments are located in the manner following:

Oak 6 inch S62°E 25.90 feet scribed SMC S19 BT

Elm 4 inch S22°W 61.10 feet scribed SMC S19 BT

Steel sign post 72 inches long due south 4.10 feet with Forest Service signs 54-2 and 54-4 attached.
