





## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 9th day of December, 1963, I found the Quarter corner of Sections 23 - 24 which was evidenced by a 1 1/2" diameter iron pipe marking corner.

Remer Ranger's office field book for T142N, R26W, shows F.S.L.P. on 5" Oak to corner west 9.9 feet. Found F.S.L.P. on 10" Oak 12 feet east of iron pipe.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
