

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 21st day of November, 1963, I found the section corner of sections 4-5-8-9 which was evidenced by 2 inch diameter capped pipe stamped:-

Set by Cass County Surveyor Flynn in 1920.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 60 inch long galvanized steel monument filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-
