That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 8th day of September, 1969, I found the Center East 1/16 corner of Section 17 which was evidenced by remains of the G.L.O. resurvey of 1919 consisting of 1 inch diameter post 3 feet long with brass cap marked C E 1/16 C

W. Oak 12 inch S31°15'E 79.86 feet - now a 20 inch at record bearing and distance
