

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

S.M.C. on the reestablished original meander line 28.75 chains south of the Quarter  
 Corner to Sec.'s 8 - 17 ..... T. 141 N ..... R. 29 W ..... No. 222

Peter J. Meyer ..... , being first duly sworn, deposes and says:

That I reside at Cass Lake ..... , Minnesota ..... , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 11th ..... day of February ..... , 1963, I found the Special Meander ..... corner of Section 17 ..... which was evidenced by the remains of the S.L.O. resurvey of 1918.

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:-

Red oak 12 inch S50°15'E 10<sup>0</sup> links (71.28') (Now a 15 inch oak at record bearing and distance with blaze facing corner.)  
 Red Oak 18 inch S1°W 20 links (13.2') (Now a 20 inch oak at record bearing and distance with blaze facing corner.)

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due North 4.2 feet.
