

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 7th day of May, 1963, I found the Angle Point 7 corner of section 17 which was evidenced by remains of the G.L.O. resurvey of 1918 corner was found to be marked by a 1 inch diameter iron pipe with a brass cap stamped

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the G.L.O. brass cap is in good condition.
