

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec's. 34-35 T. 141N R. 30W No. 534

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 9th day of June, 1965, I found the standard corner of Sections 34-35 which was evidenced by a 1 1/2 inch diameter iron pipe at corner location.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized steel monument filled with concrete and capped with a 3 inch diameter bronze tablet stamped.

Note: This point falls on top of large rock 6 feet X 6 feet approximately across so monument is only 2 feet in ground.

It is built up with rocks. Lashed County pipe to base of new brass from which reference or witness monuments are located in the manner following:

Steel sign post 72 inches long set 2 1/2 inches in ground with Forest Service signs 54-2 and 54-4 attached due West 7.5 feet.
