





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 9th day of July, 1969, I found the Section corner of Sections 30-31-25-36 which was evidenced by remains of the G.L.O. resurvey of 1918 consisting of 1 inch diameter iron post 16 inches long, 24 inches below road surface - brass cap had been cut off
 W. Oak 24 inch N22°30'E 133.98 feet - not found
 Poplar 12 inch S16°45'E 96.36 feet - not found
 W. Oak 14 inch S4°30'E 90.42 feet - not found
