



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 22nd day of May, 1962, I found the Quarter corner of Sections 7 - 12 which was evidenced by the remains of the G.L.O. dependent resurvey of 1917.

White pine 8" N13¼°E 257 links (169.62') (Now a 14" white pine N13¼°E 169.62' with scribe overgrown)

Yellow pine 10" S69½°W 567 links (374.22') (Now a 24" pine stump and log section with scribe visible S69½°W 374.22')

Iron post 1" diameter with brass cap marked ¼ (found laying horizontal under road S12 | S7 surface) 1917

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter, 24" long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:-

 S12 | S7
 1962

from which reference or witness monuments are located in the manner following: RLS No. 3628

Oak 9" S57½°E 30.5' MKD ¼ S7 BT

Oak 5" S57°W 16.8' MKD ¼ S12 BT
