

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.  
 I further depose and say that on the 8th day of June, 1962, I found the North 1/16 corner of Sections 29 - 30 which was evidenced by a 1½" diameter iron pipe set by Cass County Surveyor E. R. Horst in 1921. Notes of his survey were found in Cass County Record book "C", page 447.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
