

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

South 1/16

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 30th day of September, 1966, I found the South 1/16 corner of sections 7 and 12 which was evidenced by remains of a survey by the G.L.O. in 1919.

B Oak 14 inch N47°W 121 links (Now a 20 inch N47°W 79.86 feet, scribe visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 2 foot long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped and set 4 inches below surface in East wheel track of road.
