That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 30th day of June, 1966, I found the Quarter corner of Sections 29-28 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long 1 inch in diameter with brass cap marked

Norway Pine 10 inch S7°E 215 links or 141.90 feet - Now a 18 inch Red Pine at correct bearing and distance - scribe not visible.
