






AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 24th day of June, 1964, I found the Quarter corner of Sections 28 & 29

which was evidenced by remains of a survey of County Surveyor Curo in 1913. Cedar stump 24" S73°E 32.6' to head of 20 d. spike driven in flat spot at base of bearing tree. Found at record bearing and distance from existing fence corner. Spike in place.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" diameter galvanized steel monument, 60 inches long, filled with concrete and capped with a 3" bronze tablet stamped:
