, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 3rd day of August, 1958, I found the Section corner of sections 4-5-8-9 which was evidenced by one remaining original scribed bearing tree of the Government Survey of 1873.

- (1) 14 inch Red Pine (now 28 inch with scribing visible) N. 26° E., 34 links or 22.4 feet. I checked and found no evidence of original Government corner or other original Government bearing trees.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:
