



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 21-28 T. 145 N. R. 27 W. No. 3

State of Minnesota, }
County of Cass } ss.

Peter J. Meyer, being first duly sworn, deposes and says:
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
I further depose and say that on the 1st day of December, 1958,
I found the 1/4 corner of sections 21-28
which was evidenced by one remaining original scribed bearing tree of the Government Survey of 1873.

- 6 inch tamarack (now 8 inch windfall partly decayed with scribing S. visible) S38°W, 11 links or 7.3 feet.

Corner was found to be marked with a 2 inch squared stake mostly decayed.
A check showed no evidence of original government corner or other original government bearing tree.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized, wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze stamped tablet:

R.L.S. 3628

from which reference or witness monuments are located in the manner following:

7 inch tamarack	N71½°W	20.1 feet
5 inch tamarack	S5°W	28.5 feet
6 inch tamarack	N71½°E	8.4 feet

All reference bearings are true bearings.
