





That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of May, 1963,

I found the closing corner of Sections 2 - 3

which was evidenced by the remains of the G.L.O. resurvey of 1926

Iron post 1 inch diameter with brass cap stamped:-

Original pine 36" S51°W 46 lks. (30.36 feet) Now a pine stump with scribe visible S49°W 30.36 feet.)

W. Oak 4 inch S64°E 23 lks. (15.18 feet (Now a 6 inch oak with scribe partly decayed at record bearing and distance.)
