, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 15th day of June, 19 61, I found the Closing corner of sections 1 - 6 which was evidenced by the remains of two pine bearing trees from the original government survey of 1873-

B. Pine 8" N26°W 22 links or 14.52 feet (now a Jack pine stump and windfall N26°W 14.52 feet with scribe "BT" visible.)
B. Pine 7" N15°E 29 links or 19.14 feet (now a Jack pine stub with scribe "T144N R28W S 6 CC" visible N15°E 19.14 feet.)

No other evidence of the original corner was found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long, galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-


