Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of May, 1963, I found the Center North 1/16 corner of Section 2

which was evidenced by the remains of the GLO survey of 1926 - corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped-

Poplar 10° N58° E 6½ links (42.24 feet)(now a 21 inch Aspen with scribe overgrown, at record bearing and distance.)

Poplar 10° N69° W 33 links (21.76 feet)(Now a aspen stub at record bearing and distance.)
