





AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 18th day of February, 1963, I found the East 1/16 corner of Sections 11-14

which was evidenced by the remains of the G.L.O. resurvey of 1926.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-
 Cedar 5" N 40° E 24 lks (15.84') (Now a 7" cedar N 38° E 15.84 feet with scribe "BT" visible.) E 1/16 S11
 1926

Tamarack 6" S 29 1/2° E 32 lks (21.12') (Now a 8" tamarack stub S 33° E 21.12 feet with scribe "16B" visible.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Tamarack 6 inch N 44° E 24.35 feet marked E 1/16 S11 BT
