That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 10th day of January, 1963, I found the center South 1/16 corner of section 21

which was evidenced by remains of the General Land Office survey of 1926.

Found a 1 inch diameter iron post with brass cap stamped marking corner.

S1/16 | S 21

Birch 18 inch N46°W 47 links or 31.02 feet (now a birch stump mostly decayed N46°W 31.02 feet.) 1926

Balsam 8 inch S49°W 27 links or 17.82 feet (not found.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
