

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 3rd day of May, 1963, I found the center quarter corner of section 32 which was evidenced by a 1 inch diameter iron post with brass cap stamped: C $\frac{1}{4}$ S 32 1934

Jack pine 5 inch N77-3/4°E 37 links or 24.42 feet (Now a 12 inch jack pine N 77-3/4°E 24.0 feet with scribe partly overgrown.)
 Jack pine 4 inch N65°W 33 links or 21.78 feet (Now a 9 inch jack pine N65°W 22.3 feet with scribe partly overgrown.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Jack pine 8 inch N67°E 6.6 feet marked "C $\frac{1}{4}$ S32 BT"

Jack pine 9 inch N65°W 22.3 feet rescribed "BT"

Steel sign post 72 inches long, set 24 inches in ground due North 3.9 feet.


